### **Biography**

Mr. Murphy graduated from the University of Dayton in 1973 with a Bachelor of Arts Degree before attending Loyola University New Orleans School of Law. After graduation from Loyola in 1977, he joined Chaffe, McCall, Phillips, Toler & Sarpy in the Admiralty Section and became a partner in five years. He co-founded Murphy, Rogers, Sloss, Gambel & Tompkins in 1992. The firm initially was primarily focused on maritime litigation matters involving seamen, longshoremen and passenger injury and death claims, collisions, allisions, cargo claims, and contract disputes, but soon branched out to handling commercial litigation, insurance coverage disputes, gaming industry issues and personal injury claims. He is a very experienced litigator, having tried scores of lawsuits to juries and judges in the federal and state courts of Louisiana during his 45 years of practice.

In 2013, the New Orleans Bar Association presented Mr. Murphy with its Distinguished Maritime Lawyer Award. He has been recognized by the Martindale-Hubbell as an "AV" Preeminent Peer Rated Attorney for many years.

In 2013, he attended Harvard Law School's Negotiation Institute and successfully completed the Mediating Disputes Program, where he learned advanced techniques for alternative dispute resolution. He has represented clients in mediations in hundreds of personal injury and property damage disputes. He also has acted as a maritime arbitrator in two shipbuilding contract disputes.
